Golden Triangle Ventures, Inc. is assisting the Company in commercializing the HyGrO unit for farm and home use in markets across the globe. HyFrontier Technologies, Inc. has a mission to improve global crop production efficiency by producing Hydrogen and Oxygen directly in the water stream. This technology can be used on any species of plant life in nearly any grow medium. Additionally, the system can be retrofitted to wellheads for large-scale agricultural projects, indoor grow operations, and small farms or utilized for a multitude of residential home and garden applications.

The HyGrO system is the world’s first and only molecular hydrogen & oxygen delivery system for agriculture and is a revolutionary advancement for the delivery of key nutrients to a multitude of plant species. Replicating mother nature’s effect from thunderstorms the HyGrO system delivers significant amounts of oxygen and hydrogen, which are key amendments, directly to the soil.

Hydrogen and oxygen improves plant respiration, mineral uptake, and water movement in roots, all of which have a positive impact on plant growth and productivity. The addition of hydrogen and oxygen from our HyGrO technology allows the plant to thrive at an accelerated growth rate, similar to what farmers know to be a ‘bumper-crop’ which comes from frequent thunderstorms over their farm.
